GRAFTON COUNTY COMMISSIONERS' MEETING 3855 Dartmouth College Hwy. North Haverhill, NH 03774 Tuesday, January 25, 2011

PRESENT: Commissioners Michael Cryans, Ray Burton, Executive Director Clough and Secretary Martino.

EXCUSED: Commissioner Ahern

OTHERS: Wayne Fortier and Harold Brown.

9:05 AM Commissioner Cryans opened the meeting and began with the Pledge of Allegiance.

Maintenance Superintendent Oakes began with his report *(see attached)

The geophysics and test well were discussed and Supt. Oakes said he would like to wait until spring to explore it, though he could get the RFP's out sooner. Commissioner Cryans suggested waiting a month before putting out the RFP for the engineer.

Supt. Oakes reviewed the progress of the Jail project.

Commissioner Burton asked if there were any inmates who have applied to work privately on the Jail project and Supt. Oakes said there were not. Commissioner Burton voiced his continued opinion that as far as possible, local vendors, craftsman and suppliers be used for the project.

Commissioner Cryans asked if there have been any issues with employees slipping or falling due to the amount of snow we've had and Supt. Oakes said he hasn't heard a thing so far. Director Clough said they recently had a Joint Loss Committee meeting and that was not even brought up.

Commissioner Cryans asked about snow removal and Supt. Oakes said they're already done some and will need to do more at a later date.

H. Brown brought up an issue of a member of the Maintenance staff wearing a DoC jacket with badges on it and stated that he felt that the staff member should remove the badges as he is not a member of law enforcement and should not be represented as such. Supt. Oakes said if the Commissioners wanted the badges to come off he would instruct the staff member to do so. Commissioner Cryans said that they should be removed as the staff member is an employee in the Maintenance Dept.

Commissioner Burton said that between now and the first of July he would like to see an advisory committee established to bring forth recommendations as to what should be done with the old Jail building once it is vacant. He suggested that members of the public be invited if they wanted.

Supt. Oakes said that he knew that a couple of years ago there were two options brought to the Commissioners as to the costs to demolish the building and said that to keep the

building would involve much higher costs depending on the goal. He said they are doing all they can right now to keep up with it as is.

Commissioner Cryans said he is less attached to keeping the building and that the costs are important but it would be important to know what the plans would be for it. Director Clough said that the costs for upgrade or repair would need to be justified by the usage of the building.

Commissioner Burton said that he does not want this to have to include a costly feasibility study.

W. Fortier asked how old the newer part of the building was and Supt Oakes said it was built in 1989. W. Fortier said he would be willing to sit on the committee if they do end up establishing one.

Farm Manager Kimball arrived and gave the Commissioners his report. They are milking 70 cows, shipping 10,600#'s for an average of 75#'s. Price of milk is \$17.80.

Eight bred heifers were sold at \$1000 each, 18 piglets sold at \$75 each and 200 bales of hay at \$5 each.

Chicken productivity is on decline these months and the cold weather has been difficult to work in.

Commissioner Burton noted that David Keith was recognized as the Citizen of the Year by the Lower Cohase Chamber of Commerce at Lake Morey in Fairee, VT., and Kim and Bob Gray, owners of 4Corners Farm were named Business of the Year.

H. Brown said that the County assets were sold without proper advertising and the County had again not followed the law according to RSA 28:8-a, saying that anything sold over \$300 had to be advertised for sale and the heifers were sold at \$1000.

Commissioner Burton asked Director Clough if she thought they were in compliance with the law and she said replied as far as she was aware.

Commissioner Burton asked that the Farm Manager be on the agenda when the Commissioners meet with their fellow Commissioners on the 13th of May.

Superintendent Libby arrived with his report *(see attached) There are 85 inmates in-house, 19 in Drug Court (1 in custody) and 7 out on electronic monitoring.

A Letter from JAG (Jobs for Americas Graduates) was received in honor of FTO D. Smith.

Supt. Libby and the Grafton County Dept. of Corrections received recognition from the National Committee for Employer Support of the Guard and Reserve (ESGR), which was the first one given in New Hampshire.

Erik Valentine has been named Employee of the Quarter

Grafton County Commissioners Meeting Tuesday January 25, 2011 Supt. Libby said that he really appreciated Supt. Oakes attention to detail on the Jail project.

Commissioner Cryans commented on the last GED graduation and said it is always good to see all the family members there.

Commissioner Burton moved to approve the minutes from January 18, 2011, which was seconded by Commissioner Cryans. All were in favor.

The Commissioners signed the check registers.

Director Clough updated the Commissioners on the NACo Prescription Drug Card program saying that in the month of December the average savings was \$14.74 or 29.20%. Total savings for the month was \$8581 and there were 231 users.

The revised Dispatch agreement with the town of Piermont was signed by the Piermont Selectboard for approval and was brought before the Commissioners for approval.

Commissioner Burton moved to approve the agreement which was seconded by Commissioner Cryans. All were in favor.

The Commissioners signed the agreement.

Director Clough presented three informational letters from the NH Resource and Development for State Owned Land in the towns of Warren, Lebanon and Littleton to the Commissioners in the event they had any concerns. None were noted.

Thursday at 1:30 PM Senator Jeb Bradley will be presenting information that he plans to present as future legislation regarding the NH Retirement System and NHACo Executive Director Betsy Miller asked for County representation. No specific details were given.

The budget preparation letter and schedule was presented to the Commissioners.

National County Government month is April this year and the theme is "Serving our Veteran Armed Forces and Families". Director Clough asked the Commissioners to consider what they would like to do and noted that after the open dairy barn day there is little money left in the budget for activities.

Commissioner Cryans briefly reviewed what happened at the Executive Committee meeting for Commissioner Burton.

Director Clough said that budget packets were sent to the Dept. Heads last Friday and Commissioner Cryans asked that Director Clough outline the monies that the County will not be receiving, increases to health insurance and retirement and any other increase such as the new hires at the Jail so they can be reviewed by the Commissioners ahead of time. There was a discussion about the Northern Pass and the fact that there was just not enough factual information. W. Fortier asked if the Commissioners could speak with M. King from North Country Council and see if there is anything further he can tell them. Commissioners Burton and Cryans will call M. King after the meeting and report anything they find out to Rep. Ladd.

Commissioner Burton asked Director Clough if the County is allowed to know which employees are veterans and Director Clough said she would find that out. She said that it would be nice if veterans could be invited to the Governor's Breakfast that is held for County month.

Resident Scales - Scale worked intermittently...found loose electrical lead. Soldered lead

Electric Beds - Since last report we spent \$800 more in parts to repair two additional beds
