A. Dorsett left the meeting.

N. Coates stated that the Committee has lost its quorum and therefore cannot take any action but can carry on with their discussion.

Bill Darcy asked the Committee what their plans are in regards to the USDA Grant. He questioned whether NHEC and the Broadband Committee could work together on those grant opportunities as they would both likely be applying for them. N. Coates stated that he would discuss the engineering, which would then lead into the USDA discussion. He asked. K. Glynn for an update on phase 1 of the engineering. K. Glynn gave the committee an update on the engineering and the route they plan to start with in Task Order 1. N. Coates noted that counsel has reviewed the MSA and Task Order 1, comments have been provided to eX2 and have been finalized. N. Coates reported that they are targeting November 9th for the Commissioners to sign off on the MSA and Task Order 1. This is being funded by the \$195,000 from ARPA funds, which is covering engineering the first phases of the middle mile network.

USDA Grant - K. Robinson stated that the application for the funding opportunity will be released on November 24th. They are supposed to hear from the NTIA Grant the week before this program comes out. If they receive the NTIA grant, they will not be pursing the USDA Reconnect Grant. B. Darcy further discussed the grant applications and asked questions of the Committee.

Outreach – C. Park reported that she has the October Newsletter drafted. She stated that she has included a project update as well as the funding opportunities that have been awarded and ones that are being sought. She stated that in the newsletter she has encouraged municipalities to start their design process and put K. Robinson and K. Glynn's contact information as their partners. C. Park asked where the Committee was at in regards to listening sessions. The Committee discussed future listening sessions and what information would be useful for the communities to have. J. Adams stated that this newsletter could help put pressure on the Commissioners by stating that the Committee has proposed these routes as a part of their first phase. They will look forward to their responses. It is going to show the communities and the public that this committee is doing something.

Letters of Support – C. Park stated that they are missing letters from Benton, Dorchester, Bridgewater, Lincoln and Monroe.

The Committee discussed how they plan to help with the towns to help them start planning their work. N. Coates stated that by December it would be safe to say that they will have a meeting set up with the towns involved in Task Order 1. The goal of this meeting would be for the towns to leave knowing what the next steps would be in regards to contacting K. Glynn from eX2 to help

with the design off the backbone, then contacting K. Robinson to assist with grant opportunities and put a funding plan together. The Committee further discussed goals of these community sessions.
