GRAFTON COUNTY COMMISSIONERS' MEETING

PRESENT: Commissioners Michael Cryans, Martha Richards and Linda Lauer and Admin Assistant S. Norcross.

OTHERS PRESENT: RD Monahan, FM Kimball, HRD Cramer

Commissioner Cryans called the meeting to order 9:02AM and began with the Pledge of Allegiance.

FM Kimball arrived and opened bids for the paving of one of the farm silos. There were two (2) bids and they were as follows:

Bigelow Paving - \$8,195 Blaktop- \$8,191

FM Kimball stated he will return with his recommendation.

FM Kimball then gave the following report:

- 1) We are milking seventy head and shipping 10,600 pounds. Price of milk is now \$24.55 per hundred weight.
- 2) We are averaging 76 pounds of milk per cow.
- 3) We finished second chop on Island and lower meadow and got 125 loads of haylage.
- 4) We are finishing second cut of hay today. Second cut of hay was light.
- 5) We are starting potato digging/sorting and are selling potatoes on the farm stand now; we will start selling 50 pound bags of potatoes today.

FM Kimball answered various questions from the Commissioners.

RD Monahan arrived and gave the following report:

- 1. We had a very large sale in Lebanon (\$40,349,200.00) that resulted in a \$605,238.00 tax stamp. The state of New Hampshire received 96% or \$581,028.48, Grafton County received 4% or \$24,2089.52. This amount deducted from our monthly income would have reduced our total to \$84,401.15.
- 2. On 8/5/14 I attended the Executive Council and Governor's meeting in Bridgewater at the Inn on Newfound Lake. The NH OEP and DRA gave the morning presentation on the new SEC (Site Evaluation Committee) and taxation of renewable energy facilities. PILOT (Payment in Lieu of Taxes) RSA 72:73 72:74 It was very informative presentation. Since this is such an important subject for many of the municipalities of Grafton County I plan on writing a summary for the papers.
- 3. We have consolidated our storage and operations in the basement to make room for Administration, IT, Humans Services and Grafton Conservation Districts temporary offices.

Commissioner Richards had a discussion on the tax issues on the Dorchester Church. She stated she will continue to pursue discussions with the County Attorney.

Commissioner Lauer stated that she attended the Fire Academy Dedication on Friday Ray Burton.

Commissioner Cryans "yes"; Commissioner Richards "yes" Commissioner Lauer "yes"; Commissioner Cryans stated that a majority of the board voted yes and would now go into non-public session.
