GRAFTON COUNTY COMMISSIONERS' MEETING 3855 Dartmouth College Hwy North Haverhill, NH 03774 August 6, 2019

PRESENT: Commissioners Lauer, Piper and Morris, County Administrator Libby and Administrative Assistant Norcross

OTHERS PRESENT: Sheriff Stiegler, Captain Kelley, Deputy Cherichetti, Director of Communications Andross, Nursing Home Administrator Labore, DoC Supt. Elliott, HR Director Clough

Commissioner Lauer called the meeting to order at 9:00am and began with the Pledge of Allegiance.

The Commissioners opened bids for the purchase of the Sheriff Department's MCU Towing Vehicle. Two (2) bids were received as follows:

Irwin Automotive Group – \$35,869.00 Wells River Chevrolet - \$40,808.00

Director Andross stated that he would like to take some time to review the bids and return with a recommendation. Sheriff Stiegler thanked Director Andross and his team for the work that they have done in researching what vehicle would best suit their needs.

The Commissioners then opened bids for the purchase of at least one (1) but up to two (2) 2020 Ford Police Interceptor Utilities (PIU) and at least one (1) but up to two (2) 2020 F150 Responders, depending on the price per vehicle for the Sheriff's Department. One (1) bid was received as follows:

Irwin Automotive Group – 2020 F150 Responder - \$35,069.00 2020 Police Interceptor Utility - \$32,814.00

Captain Kelly stated that he would like time to review the bid and make sure all their requirements are met.

Sheriff Stiegler then requested a bid waver for the purchase of the ten (10) plate carriers that are included in his FY20 budget. He stated that there is a savings of \$2,900 as he is able to get them through Atlantic Tactical who has a contract with a State of New Hampshire. He stated that they are \$1,175.00 each.

**MOTION:** Commissioner Piper moved to waive bid for the purchase of ten (10) plate carriers from Atlantic Tactical at a total of \$11,075. Commissioner Morris seconded the motion and all were in favor.

Sheriff Stiegler stated that he would also like to request the purchase of five (5) ballistic helmets with the \$2,900 savings from the plate carriers. He stated that he is aware that these were not in his budget. He explained that these helmets have headphones that plug into their radios as well. These would be assigned to the primary deputies that are on the road. He stated that he would like to have this approved today with the events that just took place over the weekend but understands if the Commissioners need time to think about it. The Commissioners discussed it and supported his request. Commissioner Piper thanked Sheriff Stiegler for the work they did in getting the lower price for the plate carriers.

**MOTION:** Commissioner Morris moved to allow Sheriff Stiegler to purchase five (5) ballistic helmets with the left over monies that were budgeted for the plate carrier purchase. Commissioner Piper seconded the motion and all were in favor.

Commissioner Lauer asked if everyone had a chance to read the minutes from the July 23<sup>rd</sup> meeting.

**MOTION:** Commissioner Morris moved to approve the minutes from the July 23<sup>rd</sup> meeting. Commissioner Lauer seconded the motion and all were in favor. Commissioner Piper abstained.

Commissioner Lauer asked if everyone had a chance to read the minutes from the July 26<sup>th</sup> meeting.

**MOTION:** Commissioner Morris moved to approve the minutes from the July 26<sup>th</sup> meeting. Commissioner Piper seconded the motion and all were in favor.

The Commissioners signed check registers: 3&4; 1010-1014.

CA Libby submitted the NACO Prescription Drug Report for June. There was a price savings of \$2,096.89 or a 30.31% savings with a total of 32 utilizers. Over the life of the program there has been a total savings of \$838,135.98.

CA Libby submitted the following documents for CDBG 18-405CDCA

- Authorization to Submit Claims for all three (3) Commissioners to sign.
- Professional Service Contract for Commissioner Lauer to sign.
- Sub-Recipient Agreement for Commissioner Lauer to sign and initial.

CA Libby submitted the GCDOC Superior Court Report for the Commissioners to review.

Director of Communications Andross returned with his recommendation for the purchase of the MCU Towing Vehicle. He stated that he recommends that the Commissioners select Irwin Motors with their bid of \$35,869.00 for the Ford F350 4X4 Crew Cab

**MOTION:** Commissioner Piper moved to accept Irwin Motor's bid of \$35,869.00 for the purchase of a Ford F350 4X4 Crew Cab. Commissioner Morris seconded the motion and all were in favor.

Captain Kelly stated that after reviewing the bid for the Sheriff's Cruisers they are requesting to purchase two (2) Ford Police Interceptor Utility vehicles in the amount of \$32,812 per vehicle and one (1) F150 Responder in the amount of \$35,069 from Irwin Automotive Group.

**MOTION:** Commissioner Piper moved to accept Irwin Automotive Group's bid and purchase two (2) 2020 Police Interceptor Utility in the amount of \$32,814.00 per vehicle and one (1) 2020 F150 Responder in the amount of \$35,069.00. Commissioner Morris seconded the motion and all were in favor.

Commissioner Lauer stated that she met with Kristin Ross, President of the Grafton County Bar Association, County Attorney Hornick and Maintenance Supt. Oakes to tour the Courthouse and look for any potential space for the Bar Association to use. She stated that Kristin is looking into the Circuit Court storage space and speaking with the courts.

- 1) Monthly Financial Review He stated that FM Jurentkuff hasn't been able to finish out the month yet so he will do a two (2) month review at his next meeting.
- State Budget/SB 255 Dementia Training Bill NHA Labore stated that he spoke with Rep. Ford as Commissioner Lauer had suggested. Rep. Ford stated that they are at a stalemate on the financials, specifically the business and profits tax. Everybody that has been assigned to try and negotiate the budget has all agreed that right now they are not entertaining any other language changes. They are strictly looking at money. He stated that when he found this out he emailed Kate Horgan at the DuPont Group and she suggested that they go back to this when the legislative session starts again to try and get some additional language changes. There has been a new draft of the specific wording regarding the dementia bill that is more provider friendly, specifically the nursing homes. He stated that they will try and circulate that through the legislature and see if they have any success.

He will find out later in September if it will be delayed. This will mean less paperwork in the Nursing Home. He stated that if this is delayed it will be a huge relief for the Nursing Home.
