GRAFTON COUNTY COMMISSIONERS' MEETING Department of Corrections North Haverhill, NH 03774 May 4, 2023

PRESENT: Commissioners Piper, Commissioner Ahern and McLeod, County Administrator Libby and Administrative Assistant Norcross

OTHERS: Nursing Home Administrator Labore, HR Director Clough, Supt. Elliott, Administrative Asst. Sutherland

Commissioner Piper called the meeting to order at 9:00 AM began with the Pledge of Allegiance.

# Nursing Home Administrator Labore arrived and gave the following report (\* see attached report)

- 1) Grafton County Home Association Fundraising Request Terry Martin, President of the Home Association, was present for the meeting and stated that the Home Association would like to request permission to hold a Carnival Day in September to raise funds for the Home Association. He stated that they would be looking to have a carnival that would include face painting, games, food, dunk booth and other activities. NHA Labore stated that he feels this is a neat idea and similar to something they did years ago with the family day. The Commissioners discussed it and felt it sounded like a wonderful opportunity and support it.
- 2) Masking Change for Nursing Home Staff NHA Labore explained that there have been certain allowances in place for healthcare masking requirements. When there is two (2) weeks straight of below high level transmission, the CDC allows for masking to be optional in certain areas and more freedom when it drops to moderate transmission levels. There has been healthcare facilities and nursing homes that have removed masking all together. NHA Labore explained that at Grafton County Nursing Home has been wearing the KN95 masks since March, 2022 and rather than removing masks all together they have dropped down to surgical masks. They feel this is a safe first step. He is concerned about staff not wearing masks around the residents. NHA Labore stated that Grafton County is not consistent with other facilities but feels comfortable doing this. Staff members have been very receptive to the idea and why they are taking the slow approach to it. He stated that he would continue to monitor CDC data as it comes out and play it by ear. Commissioner Piper stated that she feels NHA Labore is making a responsible decision because they have a vulnerable population and she appreciates that.
- 2) Update on Public Health Emergency End Date May 11<sup>th</sup> 2023 NHA Labore stated that there have been several educational webinars by CMS and the CDC with what to expect when the Public Health Emergency ends. The head of the Survey and Certification Division within CMS had stated that the expectation was going to be that the vaccine mandate was going to stay in place. Federal Health and Human Services have since released a statement that vaccines would no longer be mandated in healthcare facilities as of the end of the Public Health Emergency. Commissioner Ahern asked about if the vaccine mandate were to end, if this would

allow them to get more employees. NHA Labore stated that he feels that will allow the door to open to get more employees but is nervous to open that door just yet because five (5) days ago CMS stated that it was still going to be required. He stated that he would keep the Commissioners informed.

Commissioner Ahern requested to go into nonpublic session.

3) Landscape Congressionally Directed Spending Application Update – NHA Labore stated that he received an email on Monday from Senator Shaheen's office. The office has completed the review of all requests as well as the committee. There was a link to the requests that would be considered to the full committee and the County's landscaping project was on that list. He stated that it would still be a while before they know whether the County will receive funding but they have crossed the first hurtle.

# Supt. Elliott arrived and gave the following report (\* see attached)

#### General:

- 1. Administrative Assistant J. Sutherland gave an overview of her job to the Commissioners. She discussed the various responsibilities she has and answered questions from the Commissioners.
- 2. Chef Stipend Supt. Elliott stated that the two (2) remaining DOC kitchen staff have been working 50% short staffed since October of 2022. He explained that they have overhauled the

internal jail schedule for meals and their own personal lives to accommodate for the preparation and distribution of three (3) meals a day-every day for the facility. Supt. Elliott stated that he would like to request approval for \$1,500 stipends for both of his chefs totaling \$3,000. He noted that the chef's line in the budget could absorb that cost due to being down two (2) full time staff members for most of FY23.

**MOTION:** Commissioner Ahern moved to approve the \$1,500 stipend for the two chefs in the Department of Corrections. Commissioner McLeod seconded the motion and all were in favor.
